Admissions The committee shall consist of not less than four named governors (annually elected by the Governing Body) plus the Headteacher (if not a governor) or his representative if the governing body agree to such an invitation.

The quorum shall be three governors

Resources The committee shall consist of not less than four named governors (annually elected by the Governing Body) plus the Headteacher (if not a governor) or his representative if the governing body agree to such an invitation.

The quorum shall be three governors.

Teaching, Learning and Leading The committee shall consist of not less than four named governors plus the Headteacher (if not a governor) or his/her representative if the Governing Body agree to such an invitation.

The quorum shall be three governors.

Personnel and Staffing The committee shall consist of not less than four named governors (annually elected by the Governing Body) plus the Headteacher (if not a governor) or his representative if the governing body agree to such an invitation.

The quorum shall be three governors.

Capability The Capability Committee shall consist of not less than four named governors (excluding the Headteacher) who have not previously been involved in the case, or have any other involvement, e.g. relationship to the teacher subject to capability action. At least 2 reserves in order should be named.

The quorum shall be three governors.
